4. The above programmes have been granted provisional accreditation for 2 years. As such, Velalar College of Engineering and Technology, Perunduri Road, Thindal(PO) Erode-638012. should submit the Self-Assessment Report alongwith a Compliance Report at least after one year to be considered by the Engineering Evaluation and Accreditation Committee (EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendations of the EEAC will be considered by the Sub-Committee of Academic Advisory Committee of Engineering for a decision.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Velalar College of Engineering and Technology, Perunduri Road, Thindal (PO) Erode-638012. **as a whole. As such, the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of programs and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of your Institute.

Electrical And Electronics Engineering	Criterion I: VM & PEO: Insufficient evidences found. The feedback loop is not closed. Criteria II: PO: Assessment tools and processes not well established. Results are not upto the mark. Criteria III: PC: Industry interaction is inadequate. Criteria V: FC: Less number of Ph.D. holders.
Biomedical Engineering	Criterion I: VM & PEO: Adequate evidence of process required. Criteria II: PO: Validation of CO's needs improvement. Correlation between PO's and PEOs not significant. Process not defined of the assessment results toward improvement of programme. Criteria V: FC: Cadre ratio is not as per norms. More Ph.D. required.
Computer Science And Engineering	Criterion I: VM & PEO: Process used in assessment of attainment of the PEO's has to be adequately defined.
